



# 2010 MEMBERSHIP FORM REQUIREMENTS

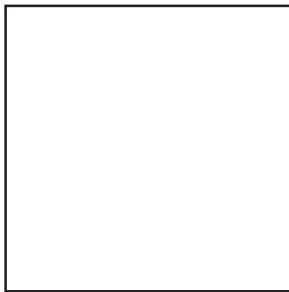
(This page for your use only, do not mail with form)



• **All memberships for the 2010 racing season MUST be accompanied by two 1<sup>1/2</sup>" x 1<sup>1/2</sup>" head shot sized photos.** This photo will be laminated on to your 2010 membership card. You must provide a photo in order to get a membership card issued to you. You can have a passport-type photo taken at your local one hour photo shop, drugstore, or any mall photo booth.

**DO NOT STAPLE PHOTOS TO THE MEMBERSHIP FORM!**

• Your photos MUST be trimmed to fit this box:



- Use this box as a template to make sure your head shot will fit inside its borders.
- Make sure you enclose two pictures.
- Your ID picture should be recent (within the last year).
- Laminated ID cards (old driver's license, last year's CVRA license etc.) will **not** be accepted.
- Your pictures should be of *your* HEAD AND FACE ONLY. No race cars, dogs, cats, deer, family members, or wedding cakes should be in the picture!
- Digital photos can be used, but they must be printed on photo quality paper and they must be trimmed to fit in the box above.

Any membership form not filled out properly will be returned to you in its entirety (check, photos, form, etc.)

Any membership form submitted with photos that do not conform to the rules above will be returned to you in its entirety.

If you are sending a membership and you are under the age of 18, then you must send a minor's release with your membership form, even if you had one on file last year. The minor's release must be identical to the one on the internet or it must be one we've mailed to you. **You must also send a copy of your birth certificate with the minor's release.**

We do not keep records on returned memberships. This means you may miss the filing deadline for the lower rate if we have to send your membership back because of errors or omissions. **Make sure they are done right the first time.**

**MAKE YOUR CHECK PAYABLE TO ALBANY-SARATOGA SPEEDWAY.**

***Your car will be registered and your membership will be accepted at both Devil's Bowl and Albany-Saratoga Speedways. If you race at both, pick the one you expect to attend more races at.***

We will also charge a **handling fee of \$30 for membership changes.** If you wish to change a car number or division *after your membership is processed*, or if you sign up as a member when you are really a car owner and we have to change your membership, you will be charged the fee of \$30. ADVERTISING RELEASE: The undersigned consents to the use of his/her name and/or pictures of himself and his car, for publicity, advertising and endorsement both before and after events and relinquishes any rights to photos or videos taken in connection with events, and consents to the publication or sale of such photos and/or videos by Albany-Saratoga or Devil's Bowl Speedway.

SAFETY RELEASE: I hereby give up all my rights to sue or make any claim against the CHAMPLAIN VALLEY RACING ASSOCIATION, ALBANY-SARATOGA SPEEDWAY, LLC, DEVIL'S BOWL SPEEDWAY, LLC and their organizers, promoters, sponsors and all other persons or organizations conducting or connected with this event for any injury to property or person I may suffer, including crippling injury or death, whether such injury arises while I am preparing for or participating in the event or while I am upon the event premises. I know the risks of danger to myself and my property while participating in the event, and while upon the event premises and relying upon my own judgment and ability, assume all such risks of loss and hereby agree to reimburse all cost to those persons or organizations connected with this event for damages incurred as a result of any injury that I cause or receive. I understand that it is my duty to take every possible means to keep my racing car and equipment in the best possible condition, using every precaution in a safe and organized manner. I further declare that my car conforms to all rules pertaining to the particular division I have entered for competition, and that same car is legal for that division. Should my car be found to be illegal, the CVRA shall have full right to enforce all rules as outlined in the CVRA Rule Book regarding said legality without recourse for me, my driver or crew. Further, I take full responsibility for my driver and my crew's professional behavior while on the grounds of the speedway. I also understand that no one under the age of 14 is allowed in the pits.

ARBITRATION: Any dispute, controversy or claim involving the undersigned member, whether or not relating to this agreement or alleged breach of same, shall be settled in accordance with the existing and/or amended rules and regulations of the Association and the undersigned agrees to accept the decision rendered in the process.

I hereby state that I have a copy of the latest Champlain Valley Racing Association Rule Book, and that I have read and understand the rules set forth in said book. I further agree that as a car owner, I will not allow anyone to drive said car who is not a member in good standing of the Champlain Valley Racing Association or who is not in the proper physical condition. IT IS FURTHER UNDERSTOOD THAT ANY AND ALL ILLEGAL PARTS FOUND ON MY CAR SHALL BE CONFISCATED BY CVRA WITHOUT CLAIM FROM ME.
